On June 29, 2010 Minnesota Public Radio ("MPR") filed a Notice of Change of Primary Station with the Commission. A copy of that letter is attached.

After filing I noticed a typo in the letter. In one place I stated that the primary station is KCMP (FM), Rosemont, MN. In a second citation, the letter refers to "KCPM (FM)". The purpose of this letter is to clarify that the correct call sign for the primary station of this translator is **KCMP (FM)**, Rosemount, MN.

The purpose of this letter is to notify the Commission of a change in the primary station of the above referenced translator.

Minnesota Public Radio ("MPR"), a noncommercial educational broadcaster, is the licensee of FM translator K237ET, New Ulm, MN. The primary station of this facility has been KNGA (FM), Saint Peter, MN. However, MPR has re-tuned this translator and its primary station was changed to KCMP (FM), Rosemont, MN. MPR is the licensee of both KNGA (FM) and of KCMP (FM) and operates both stations on a non-commercial basis. The KCMP signal is being fed off-air to K237ET.
