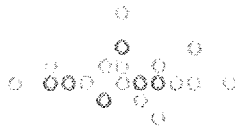

By letter filed with the Commission on August 31, 2010 (copy enclosed), in accordance with 47 CFR 73.561 (d), Minnesota Public Radio ("MPR"), licensee of KMSE-FM informed the Commission that KMSE had been operating at about 80% of its authorized power. 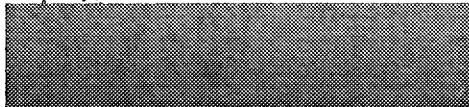
Dear Ms Dortch:

In accordance with 47 CFR 73.561 (d), Minnesota Public Radio ("MPR"), licensee of KMSE-FM, hereby informs the Commission that KMSE has been operating at about 80% of its authorized power since August 18, 2010 and is expected to be operating at reduced power for another few weeks.

For reasons we are uncertain about, the transmitter is not working correctly. MPR is working diligently towards solving the problem and all reasonable efforts will be made to get KMSE back up to its authorized power as soon as possible.


