Dear Ms Dortch:

As of today KRSW is listed on the FCC database as "silent". The purpose of this letter is to inform the Commission that KRSW is back on the air at full power.

The history of this is that in accordance with 47 CFR 73.561 (d), Minnesota Public Radio ("MPR"), licensee of KRSW-FM, Worthington, MN, filed an Engineering STA on February 1, 2010, informing the Commission that MPR was temporarily been operating KRSW-FM at reduced power. The Commission granted an STA on April 14, 2010. However, by letter filed March 19, 2010 (copy attached), MPR notified the Commission that the station was back up to full power.

The purpose of this letter is to confirm with the Commission that KRSW is back on the air at full power and the STA is no longer needed.

An Anti-Drug Abuse Act certification form is attached. MPR is a noncommercial educational licensee, therefore, no fee is required for this filing.
