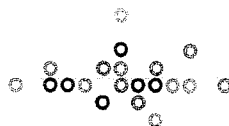

Dear Ms Dortch:

In accordance with 47 CFR 73.561 (d), Minnesota Public Radio ("MPR"), licensee of WIRN-FM, Buhl, MN, hereby informs the Commission that as of December 8, 2009 WIRN began operating at about 75% of its authorized power. A transmission line problem is causing the reduced power operations. Repair of the problem is anticipated to take more than 10 days.

All reasonable efforts will be made to resolve the problem and to get the station back up to its authorized full power as soon as possible.
